Pleading guilty typically results in a more lenient punishment for the defendant; it is thus a type of mitigating factor in sentencing. A plea bargain is when a defendant makes a deal with the prosecution or court to plead guilty in exchange for a more lenient punishment, or for related charges against them to be dropped.
